2021/5EE/4 To consider the following planning applications:

Application 21/0455 – The Coppice, Kirkham – Formation of pitched roof over existing garage, extension to rear of garage, and other alterations associated with use of garage as habitable accommodation for the property – The Council had no objections - Agreed

Application 21/0460 - 21 Roman Way, Kirkham - Single storey side extension to form garage – The Council had no objections - Agreed

Application 20/0835 - Little Tarnbrick Farm, Blackpool Road, Kirkham – Amended plans - Reduction in number of dwellings from 7no. to 3no., revised external and internal access arrangement, and additional tree planting to roadside – The Council refused this application due to concerns regarding flooding, sewage and another entrance onto a very busy road. Agreed

Application 21/0411 - 23 Moor Street, Kirkham - Change of use from dwelling and workshop to form two dwellings with associated external alterations to windows and doors and the creation of external amenity space and bin stores. – The Council approved this application subject to concerns as to how the bin store and amenity space are accessed. Agreed
